Sir,

I am directed to refer to your letter No. F.38/RR&DM/Visit RR Camps/06-07 (Part)/213-15 dated 12.08.2015 addressed to Ministry of Home Affairs (NE.II Division) on the above subject and to say that in pursuance of recommendation of the Ministry of Home Affairs, vide its I.D. No.7/3/98-NE.II (Pt.II)/NHRC dated 17.08.2015 and 19.08.2015, it has been decided to make additional allocation of 532.248 MT of rice per month to Tripura at FCI's applicable economic cost from October, 2015 to March, 2016 for maintenance of Bru migrants in the State. FCI will intimate the applicable economic cost to the State Government.

2. The validity period for deposit of cost and lifting of rice against this allocation will be as per the instruction issued vide this Department's letter No.1-2/2007-BP.III dated 11.07.2012. Accordingly, the allocation for the month of October, 2015 is to be lifted by the end of September, 2015 and so on.
