Sir,

I am directed to refer Government of Haryana's letter F.No.59/FG(3)/2018/21341 dated 1.10.2018 on the above subject and to say that it has been decided to allocate 1,00,000 tons of Bajra and 15000 tons of Maize under NFSA to Haryana in the month of November, 2018 to January, 2019 by reducing equivalent quantity of wheat allocation of the above said three months. Accordingly, in partial modification of this Department's allocation letter No.1-3/2014-BP.III dated 31.10.2017, the revised monthly allocation for the months of November, 2018 to January, 2019 to Haryana under NFSA will be as under:

If any quantity of wheat for the month of November, 2018 already lifted in excess of the above revised allocation, the same may be adjusted in the allocation of subsequent month(s).
