Sir,

I am directed to refer to State Govt.'s letter No. 9/11/99-FCS(Pt.I) dated 30.8.2018 on the above subject and to say that on account of revised identification of beneficiaries under NFSA reported by the Govt. of Manipur and based on the AAY & Priority beneficiary list uploaded on the portal, the monthly allocation of foodgrains to the State of Manipur under NFSA is revised from November, 2018 onwards.
