Subject: Revised monthly allocation of foodgrains under TPDS for AAY/BPL families of Odisha w.e.f. December 2013. - reg.


I am directed to refer to your letter No. EC-AAY-6/13/8505/FS&CW dated 26.10.2013 and this Department's letter No.6(5)/2005-PD.III dated 29.11.2013 on the above subject and to say that in view of that out of total target of 12.645 lakh AAY families in the State of Odisha the State Govt. has so far identified 12,53,344 AAY families. It has therefore been decided to revise monthly TPDS allocation for Odisha by increasing 4 tons of rice per month under AAY category and corresponding decrease under BPL category with effect from December, 2013 onwards. Accordingly, in partial modification of this Department's allocation letter No.1-1/2013-BP.III(21) dated 26.2.2013 and subsequent allocation letter No.2/Odisha/2013-BP.III dated 4.10.2013, the revised monthly TPDS allocation to Odisha for AAY and BPL families with effect from December, 2013 to March 2014 will be as follows:

2. The validity period for deposit of cost and lifting of the allocation for the month of December 2013 and January 2014 will 50 days from date of issue of this letter. The validity period for the rest of the months will as per existing instructions applicable for normal TPDS allocation. In case any quantity of rice already lifted against December, 2013 and January 2014 allocation in excess to the above revised allocation, the same may be adjusted against the allocation of subsequent months.
3. Other terms & conditions as mentioned in this Department's allocation letters No.1-1/2013-BP.III (21) dated 26.2.2013 will remain unchanged.
