Subject: - Allocation of foodgrain (rice) under TPDS to Lakshadweep for the year 2013-14 (October 2013 to September 2014).


Sir,

I am directed to refer to your letter F.No.130/6/2011-CS(Part)/263 dated 22.7.2013 on the above subject and to say that the UT Administration has been allocated following monthly quantities of rice for AAY, BPL and APL families, under TPDS, for the current year 2013-14 (October 2013 to September 2014):

2. The Administration of Lakshadweep is allowed to lift the allocated quantity of rice for the year 2013-14 in one or more instalments as per their convenience. Therefore, the validity period for deposit of cost and lifting of the above allocation will be upto 30<sup>th</sup> September 2014.
3. The foodgrains allocated under TPDS should be utilized only for the purpose for which the same have been allocated and not for any other purpose/scheme. This is in consonance with the Utilization Certificate which is mandatory and is required to be regularly furnished by the UT Administration under PDS Control Order, 2001 on monthly basis.
4. FC) is requested to make available the allocated quantity of Grade 'A' rice (slender variety, par boiled, polished and white colour) and deliver the same in double gunny bags in its Mangalore depot for arranging transshipments to 10 inhabited Islands of the UT after South-West monsoon. The additional cost towards double gunny bags and labour cost, etc shall be borne by the UT Administration.
5. The above allocation will remain valid till implementation of National Food Security Ordinance.
