I am directed to say that maize and jowar has been procured for Central Pool in Maharashtra and considering the availability of maize and jowar, Government of India has decided to make allocation of 38262 tons of maize and 65 tons of jowar by substituting same quantity of wheat for the month of February, 2014 at Central Issue Price (CIP) of Re. 1/kg. Accordingly, in partial modification of this Department's allocation order No. 1-8/2013-BP-III dated 27.01.2014, the monthly allocation of foodgrains to Maharashtra under NFSA for the month of February, 2014 will be as under:
