Sub: Revised monthly allocation under TPDS to Arunachal Pradesh, Mizoram and Nagaland with effect from October 2013 onward – reg.

Sir,

I am directed to refer to this Department's d.o. letter of even number dated 13.9.2013 and confirmation received from the State Governments on conversion of monthly allocation of wheat under TPDS into rice and to say that it has been decided to convert entire quantity of wheat allotted under monthly TPDS allocation for the States of Arunachal Pradesh, Mizoram and Nagaland into rice. Accordingly, in partial modification of this Department's allocation letters No.1-1/2013-BP.III dated 26.2.2013 and 25.3.2013, the monthly TPDS allocation to the above States from October 2013 to March 2014 or till implementation of NFSA will be as under:

2. The validity period for deposit of cost and lifting of the allocation for the month of October will be 50 days from the date of issue of this letter. In case any quantity of wheat has already been lifted, the same may be adjusted against the revised allocation for the subsequent months. Other terms and conditions as mentioned in this Department's allocation letters dated 26.2.2013 and 25.3.2013 will remain unchanged.
