i.Management of Public Distribution System (PDS) operations in the country through efficient procurement at Minimum Support Price (MSP), storage and distribution of foodgrains (cereals)ii.Ensuring availability of foodgrains, sugar and edible oils through appropriate policy instruments; including maintenance of Buffer Stocks of foodgrainsiii.Making foodgrains accessible at reasonable prices, especially to the weaker and vulnerable sections of society.
