Sir,

I am directed to refer to your letter No. F.11(3)/RR&DM/Reang/2017/33 dated 25.09.2017 addressed to Ministry of Home Affairs (NE.II Division) on the above mentioned subject and to say that in pursuance of recommendation of the Ministry of Home Affairs, vide its I.D. Note No.7/3/98-NE.II (Pt.II)/NHRC dated 28.09.2017, it has been decided to make additional allocation of 508.710 MT of rice per month from October, 2017 to March, 2018 to Tripura at FCI's applicable economic cost for distribution to Bru migrants in the State. FCI will intimate the applicable economic cost to the State Government.

2. The validity period for deposit of cost and lifting of the above additional allocation for the month of October and November, 2017 will be 30 days from the date of issue of this letter. The validity period for rest of the months will be as per the existing instructions conveyed vide this Department's letter No.1-2/2007-BP.III dated 11.07.2014.
