**Subject: Revised allocation of additional free of cost foodgrains to NFSA beneficiaries under PRADHAN MANTRI GARIB KALYAN ANNA YOJANA (PMGKAY Phase VI) for a period of 5 months i.e. from May to September, 2022- reg.**

Sir/Madam,

In supersession of this Department's letter of even number dated 3<sup>rd</sup> May, 2022, I am directed to refer to this Department's letter of even number dated 28.03.2022 and to say that this Department had made an additional allocation of foodgrains, under PMGKAY VI, free of cost foodgrains @ 5 kg per person per month to the beneficiaries covered under NFSA (AAY, PHH & DBT) over and above NFSA allocation for a period of six months, i.e. April, 2022-September, 2022.

2. In order to ensure management of foodgrain stocks as per norms, to position rice stock for distribution of fortified rice, to ease the pressure on the logistics and after consultations with respective States, it has been decided to revise the PMGKAY-VI allocation of rice and wheat for all the 36 States/UTs for the remaining 5 months i.e. May-September, 2022 as per **Annexure**. The allocation for April, 2022 will remain same as communicated initially vide letter dated 28.03.2022.

3. The lifting period for these revised additional foodgrains for May and June, 2022 will be upto 31.05.2022. The validity period for lifting of the above additional allocation for rest of the months i.e. July-September, 2022 will be upto last date of the month preceding the allocation month. Further, the States/UTs may at their discretion lift their respective additional allocations in one go also, earlier subject to availability of stocks with FCI within the State/UT.

4. There will however be no change in other terms and conditions mentioned in this Department's allocation order dated 28.03.2022.

5. The Government of India will bear the entire cost on account of such distribution including food subsidy, intra-state transportation and dealer's margin/additional dealers margin, without any sharing by States/UTs.

6. This issues with the approval of competent authority vide Note No. 1323 dated 02.05.2022 and subsequent concurrence of IFD vide its Note No. 1327 dated 02.05.2022.
